MCRA hears possible revenue stream for development

WILLIAMSON — The Mingo County Redevelopment Authority (MCRA) heard information about a possible source of revenue to be used for economic development in the state.

Paul Miller, Policy Outreach Director for the West Virginia Center on Budget Policy (WVCBP), discussed creating an economic diversification trust fund in the state to take advantage of the boom in Marcellus shale gas income.

Miller outlined the fund, which will be presented to the West Virginia legislature. He said the concept works in the same way as coal severance tax in that taxes are collected on the gas produced from Marcellus shale. But how the money would be used is a new, forward-thinking concept. The economic diversification trust fund money would be used specifically for economic development within the state.

Rick Wilson, also with WVCBP, said West Virginia's economy is based on limited natural resources, minerals such as coal and gas.

"This is a way to change the way we approach our resources," Wilson said. "They are not renewable, we need to set aside some of that income to create permanent wealth."

Money from taxes on minerals would be collected and put into the fund. The rate of the amount set aside in the fund would depend on the legislation used to create the fund. When the fund grows to a predetermined amount, part of the interest on that money would be used for economic development. The principal in the fund would not be touched, he said.

Legislators in Charleston would determine how the money was spent.

Miller said he has been working with economic development boards and county commissions across the state to get input on how they felt money from a trust fund should be used.

Wilson explained that other states which rely on natural resources have been building their mineral trust funds for years.

Alaska, for example, receives monies from mineral leases and royalties and had, as of October 2011, over \$39 billion dollars from a fund created in 1976. Wyoming receives a 2.5 percent tax on gas, oil and coal, and has well over \$5 billion in its fund.

Paul Miller said the state's budget is increasingly being funded by coal severance tax income, 11.5 percent of West Virginia's general revenue was coal severance money last year.

"We are growing more dependent on coal severance tax," Miller said. "And as long as coal sales are up, that's great. But estimates are that coal production will go down 36 percent by 2025. As the coal business decreases, Marcellus shale increases. This is a way to take advantage of that."

West Virginia has the fifth least diversified economy in the nation, Wilson said, and Mingo County's economy has one of the least diversified economies in the state.

He said that by using a trust fund for economic development, the state will be able to provide things such as infrastructure and broadband internet, early childhood development, workforce development and clean energy programs.

MCRA member James Simpkins noted that money that is set aside is money that will not be put into the state's economy now.

"We would only need this fund if we don't have the ability to manage this new income," Simpkins said. "Why would this be better than a 'rainy day' fund, or sound financial practices?"

"A 'rainy day' fund is for emergencies," Miller said. "This is a more pro-active way to invest in the future of the state's economy."

Simkins agreed that the fund would be good for the state if it were used solely for economic development.

"It would be too broad," Simpkins said. "If it were used just for economic development, that would be using money to make money. But in the Legislature, everyone wants a piece of the pie. It seems to me it would create more bureaucracy."

Wilson said representatives in Charleston may not support the fund for political reasons.

"We need to challenge them to look beyond the next election cycle," he said. "Some of them lack the political will to do so. They need to think long-term and create something permanent from something with a finite lifespan."
