§17B-4-3. Driving while license suspended or revoked; driving while license revoked for driving under the influence of alcohol, controlled substances or drugs.

(b) Any person who drives a motor vehicle on any public highway of this state at a time when his or her privilege to do so has been lawfully revoked for driving under the influence of alcohol, controlled substances or other drugs, or any combination thereof, or for driving while having an alcoholic concentration in his or her blood of eight hundredths of one percent or more, by weight, or for refusing to take a secondary chemical test of blood alcohol content, is, ; for the second offense, the person is guilty of a misdemeanor

FACTS

On August 3rd, 2024 I Deputy R. King of the Harrison County Sheriff's Office was on routine patrol on West Pike Street when I observed a Silver Kia Optima bearing West Virginia 6YP321 with an expired registration of June 2024 and, also observed an improper turn made by the vehicle onto West Main Street.

I then conducted a traffic stop on the vehicle at the GoMart in Downtown Clarksburg, Harrison County , West Virginia. As I approached the drivers side of the vehicle I observed a white female behind the wheel who was later identified as Marissa Crim. Ms. Crim openly stated when asked for drivers license that she did not have one and was suspended, I then gathered all of Ms. Crim's information and had Headquarters run her information upon which a short time later they advised Ms. Crim was suspended and had an previous driving revoked DUI from 5-27-2018 and current revocation date of 3-25-2024. I then placed Ms. Crim under arrest for the driving with an Active DUI and contacted her Grandfather to retrieve the vehicle.

Ms. Crim was then transported to staging where she was then processed and fingerprinted and then transported to NCRJ.
